### PAYMENT INFORMATION:

Full payment, in the form of cash, check, or credit card is due prior to class beginning. I understand that in order to secure my spot in class I must pay in full. This tuition is non-refundable. A charge of \$25.00 will incur for each returned check.

### POLICYS:

- \_\_\_\_\_ My canine is currently vaccinated as age appropriate
- \_\_\_\_\_ I will keep my dog leashed on a static leash at all times unless otherwise instructed by the trainer
- \_\_\_\_\_ I will bring my dog's favorite treats and or toy to each class
- \_\_\_\_\_ I will not let my dog approach another dog unless instructed to by the trainer
- \_\_\_\_\_ I will not approach another pet parent's dog unless I ask the pet parent for permission
- \_\_\_\_\_ I will notify my trainer of any special needs my dog has prior to the beginning of class
- \_\_\_\_\_ I will not use inhumane training techniques or gear in this class
- \_\_\_\_\_ All dogs will be accompanied by an adult
- \_\_\_\_\_ I understand that I must clean up after my dog
- \_\_\_\_\_ I understand that in order to see results I must practice the protocols taught in class

### AGREEMENT:

The Client acknowledges that dog training may not provide exact results. The Client understands that dog training is not without risk to themselves, members of their family/household, guests, or their dog(s). The Client hereby agrees to hold Canine Companion Consulting, agents, and assigns free and harmless from any and all claims; or claims made by any member of any family or any other person accompanying them to any training session. Should any behavior of the Client's dog now, or in the future, result in damage to property or person of Client or some third party, the Client agrees to assume full liability for any and all such damage, and absolves Canine Companion Consulting from any and all liability for obligations to pay for such damage, loss, and or expenses arising out of any injury to any person or to any person's property by the dog(s) named in this contract.
